In consideration of my use of facilities or participation in events organized or sponsored by M.R.A. and COUNTY OF HUMBOLDT, its directors, officers, agents, and members, their representatives, heirs, executors and assigns from any and all, I release claim or liability for injury or damage to myself, my animals or my property arising out of my participation. This agreement is binding on my executors, heirs and assigns.

I expressly waive any rights I may have under California Civil Code 15742, which states; "A general release does not extend claims which the creditor does not know or suspect to exist in his favor at the time of executing the release, which if known by him must have materially affected his settlement with the debtor".

I agree that I will defend, indemnify and hold harmless **M.R.A. and County of Humboldt**, its officers, directors, members and agents against all claims, demands, and causes of action including court costs and actual attorney's fees, arising from any proceeding brought by or prosecuted for my benefit, in which this release is upheld.
